### REPAIR/REPLACEMENT OF LEFT & RIGHT SPAR ASSY OF B-200 AIRCRAFT OF THE SRI LANKA AIR FORCE

1. The Chairman, Ministry Procurement Committee, Ministry of Defence, No. 15/5, Baladaksha Mawatha, Colombo 03, Sri Lanka on behalf of Secretary, Ministry of Defence No. 15/5, Baladaksha Mawatha, Colombo 03, Sri Lanka now invites sealed bids from eligible and qualified bidders for Repair/Replacement of Spar Assy –LH Outboard Wing Front (Part No 101-110084-1) and Spar Assy –RH Outboard Wing Front (Part No 101-110084-2) of B-200 Aircraft of the Sri Lanka Air Force.

**NOTE. TO PERFORM THE REPAIR/REPLACE, BOTH WINGS NEED TO BE COLLECTED BY THE REPAIR PLANT/SERVICE PROVIDER FROM THE SRI LANKA AIR FORCE.**

2. The delivery to the repair plant, accomplishment of the repair/replacement and re-delivery after repair/replacement of the spar assys of both wings shall be completed within **45 DAYS** which is calculated from the date of receiving both wings from nearest seaport/airport to the SERVICE PROVIDER.

3. Bidding will be conducted through International Competitive Bidding Procedure (ICB).

4. The referred Aircraft can be inspected at the No. 3 Squadron, Sri Lanka Air Force Academy China-bay, Trincomalee, Sri Lanka from 07<sup>th</sup> June 2019 to 21<sup>st</sup> June 2019 at 0900 hours to 1500 hours on every working day.
