The Chairman, Ministry Procurement Committee, Ministry of Defence, No. 15/5, Baladaksha Mawatha, Colombo 03, Sri Lanka on behalf of Secretary, Ministry of Defence No. 15/5, Baladaksha Mawatha, Colombo 03, Sri Lanka now invites sealed bids from eligible and qualified bidders for the Programmed Depot Maintenance (PDM) of C-130 Aircraft (Aircraft Registration No. SCH-881 S/No. 3824240) of the Sri Lanka Air Force.
2. Bidding will be conducted through International Competitive Bidding Procedure (ICB).
3. The aircraft should be serviced at the facility in Sri Lanka Air Force Base Katunayake within a specific time period determined by the service agency (should be less than 180 days) and the said time period to be clearly mentioned in the bid.
4. It is mandatory for a representative (a competent inspection team nominated by the service agency) to carry out an inspection of the referred aircraft at the No. 2 Squadron, Sri Lanka Air Force Base Katunayake, Sri Lanka from 03rd June 2019 to 17th June 2019 at 0900 hours to 1500 hours on every working day. The bidders, who fail either to carry out the said pre bid inspection of the aircraft or to submit the inspection report along with the bid, will be disqualified.
