MEMBERSHIP

a) Eligibility

Regular Officers, Women Officers, Airmen and Airwomen of the Sri Lanka Air Force who complete a minimum period of five year regular service and have left the Air Force and Volunteer Male and Female members with a minimum of a total of five years mobilized service. Shall be eligible for membership of the Association Officers and women officers and women officers who have relived of their commissions and airmen and airwomen who have dismissed from the service and those who have convicted from the Criminal will not be eligible for membership In the Association.

b) Person will be admitted as a member only after producing 1st & 2nd and the last page of discharge certificate.

c) Application

- i. Admission for membership shall be on application made to the Board of Management.
- ii. An application may be rejected by the Board if Management. but any person aggrieved by such decision may appeal to the Association for re-consideration of his / his application.
- iii. An application submitted on appeal to the Association for re- consideration shall be accepted lf is passed by the majority of votes of members in voting at a meeting of the Association, at which the appeal is taken up for decision.

d) Life Membership Rates :

A person whose application for membership if accepted may, on payment of a fee mentioned below be admitted as a member.
