



# SRI LANKA AIR FORCE

## REGISTRATION OF FOREIGN SUPPLIERS FOR AIRCRAFT MAINTENANCE, SPARE PARTS, COMPONENTS AND SERVICES - 2025

- The Sri Lanka Air Force (SLAF) invites qualified suppliers to register for **aircraft maintenance, repair, overhaul, and related support services**.
- Organizations with expertise in aircraft maintenance, avionics, radar systems, and other critical areas in aviation industry may apply for a range of aircraft and systems. This includes, but is not limited to, support for: helicopters such as the Bell series (206, 212, 412, 412EP) and Mi series (Mi-17, Mi-24); fixed-wing aircraft including F7GS/F7BS/FT7BS, K-8, Y-12, Cessna 150, C-130, Beechcraft (B-200T, B-350, B-360), Kfir (TC2, C2, C7), AN-32B, MA-60, Dornier aircraft, Tiger Moth DH82, Siai Marchetti SF260, and Chipmunk DHC-1; unmanned aerial vehicles (UAVs) / drone systems; avionics equipment and spares; and RADAR systems such as INDRA Mk II, YLC-18, JY II, and Air Traffic Control (ATC) RADAR systems. These systems also include associated communications, navigation, electronic warfare, and air traffic control systems.
- Application Process:**
  - **Download :** Obtain the application form (comprising Sections A-H) and the detailed category list from the official Sri Lanka Air Force website, accessible **from 06 February 2025 to 27 March 2025** (URL: [https://www.airforce.lk/main\\_tender.php](https://www.airforce.lk/main_tender.php)).
  - **Fee :** USD 50 per category (if paid directly by a Foreign Principal) or Rs 15,000 per category (if paid through a Local Agent or Local Supplier).
  - **Payment : Bank :** Bank of Ceylon, **Account Name :** Commander of the Air Force, **Bank Number :** [7010], **Account No.** [0007041353], **Swift :** [BCEYLK LX], **Branch :** [Taprobane Branch], **Branch Number :** [747], Attach the original deposit slip (Fees are non-refundable; Applications received with late payments will not be accepted).
  - **Submission :**
    - **Preferred Method: Submit the complete application as a single PDF file to [lquote@slaf.gov.lk](mailto:lquote@slaf.gov.lk) by 1600 hrs local time on 28 March 2025.**
    - **OR** Registered post or hand-delivery to: Chief Procurement Officer, Procurement Division, Sri Lanka Air Force Headquarters, P.O. Box 594, Defence Headquarters Complex, Sri Jayewardenepura, by **1600 hrs local time on 28 March 2025.**
    - For email submissions, a scanned copy or clear photograph of the deposit slip is required within the PDF file. For physical submissions, the original deposit slip must be included.
  - **Application Requirements :** Complete all Sections (A-H) in English. Attach certifications, financial statements, and references **in English or certified translations**.
  - **Section A1 should be completed when Local Agents / local suppliers are involved.**
- Registration and Framework Agreement :**
  - Selected suppliers will enter into a Framework Agreement with the SLAF, **valid for three years, subject to annual renewal based on performance and operational requirements.**
  - Suppliers registered under the Framework Agreement will be invited to **participate in competitive bidding for specific call-offs under their registered category.**
- Other Conditions:**
  - Registrations would be considered subject to an assessment/evaluation procedure and will be rejected if the information provided is found to be false or inaccurate.
  - Calling of quotations for supplies and services will be invited from the list of suppliers/service providers registered under the Framework Agreement.
  - Registered suppliers who fail to meet deadlines and maintain quality and standards up to the desired levels would be black-listed and removed from the Framework Agreement.
